Resolutions and Notes (unanimously agreed, unless otherwise noted):

56.01 Project Editor for the Revision of ISO/IEC 14443-1 and 10373-6

WG8 appoints Mr. Erich Reisenhofer, Austria, the Project Editor for ISO/IEC 14443-1 and 10373-6, due to the unavailability of the formerly appointed Mr. Peter Raggam.

56.02 Revision of ISO/IEC 14443-1

WG8 invites its members and the members of TF2 to send contributions related to the Revision of ISO/IEC 14443-1, in particular comments to the Working Draft WD Revision 14443-1, i.e. WG8 N 22xx. Contributions and comments should be sent to the WG8 Secretary for distribution within TF2 and to the TF2 Convener Mr. Pascal Roux no later than 7th of September 2014.

56.03 COR2 10373-6:2011

WG8 instructs the Project Editor of COR2 of 10373-6:2011, Mr. Stéphane Jobard, to send its revised text and the related Disposition of comments document on the ballot comments to the WG8 Secretariat no later than 30th of April 2014. The WG8 Secretariat shall send out those texts to the participants of that WG8 meeting for a checking period of three weeks, starting no later than on 7th of May 2014. Editorial corrections, if any, have to be sent to the Project Editor and to the WG8 Secretariat at no later than the end of the checking period. When comments are received by the WG8 Secretariat it is instructed to forward those comments at once to the participants of this meeting for information. The Project Editor is instructed to send the possibly refined text to the Project Editor of ISO/IEC 10373-6 for integration into its 3rd edition. WG8 Convener is instructed to inform the SC17 Secretariat and the Project Team of ISO/IEC of that procedure.

56.04 DIS 10373-6:2011/DAM5 (Extension of PICC and PCD test methods)

WG8 instructs the WG8 Secretariat to forward the final text of DAM5, together with the related Disposition of Comments document, to the SC17 Secretariat for DIS ballot at no later than the 16th of April 2014, after the TF2 Convener Mr. Pascal Roux and Mr. Kenichi Nakamura (Japan) will have checked the final DIS text.

56.05 DIS 18745-2 (MRTD test methods of the contactless interface)

WG8 instructs the Project Editor of 18745-2, Mr. Stéphane Jobard, to send the DIS text and the related Disposition of comments document on the 2ndCD ballot to the WG8 Secretariat no later than 31st of May 2014. The WG8 Secretariat shall send out those texts to the participants of that WG8 meeting for a checking period of three weeks, starting no later than on 7th of June 2014. Editorial corrections, if any, have to be sent to the Project Editor and to the WG8 Secretariat at no later than the end of the checking period. When comments are received by the WG8 Secretariat it is instructed to forward those comments at once to the participants of this meeting for information. The Project Editor is instructed to send the possibly refined text to the WG8 Secretariat one week after the end of the checking period. The WG8 Secretariat shall then forward the final text to the SC17 Secretariat for the next procedural step at no later than the 15th of July 2014.

56.06 DIS 15693-3/DAM2 (Clarification of optional flag)

WG8 instructs the WG8 Secretariat to forward the final text of DAM2, together with the related Disposition of Comments document, to the SC17 Secretariat for DIS ballot at no later than the 16th of April 2014.

56.07 DIS 15693-3/DAM3 (Extended VICC memory organization)

WG8 instructs the WG8 Secretariat to forward the final text of DAM3, together with the related Disposition of Comments document, to the SC17 Secretariat for DIS ballot at no later than the 16th of April 2014.

TF3 is instructed to hold a meeting no later than in July 2014 for considering and possibly specifying an improvement, which is intended to be used as a comment to the DIS ballot of DAM3.

56.08 Revision of 10373-7 (VICC test methods)

WG8 invites its members to propose candidates for the role of the Project Editor on the Revision of 10373-7.

56.09 Liaison Officer from the NFC Forum to WG8

WG8 welcomes Mr. Michael Stark as the new Liaison Officer from the NFC Forum to WG8. WG8 expects that the NFC Forum Secretariat will send the information of the formal assignment of Mr. Stark to the SC17 Secretariat in due time.

56.10 Liaison Officer from WG8 to the NFC Forum

WG8 appoints Mr. Erwan Le Fer the Liaison Officer from WG8 to the NFC Forum and asks the SC17 Secretariat for endorsement and for formal information to the Secretariat of the NFC Forum.

56.11 Application Profile for the contactless interface of MRTDs

WG8 instructs its Convener to generally present the current discussion of the draft Application Profile for the contactless interface of MRTDs, and raise related questions of WG8 at the WG3 meeting in Tokyo, held on 2014-04-14/16, and to ask WG3 members for feedback. The existing draft can then be appropriately updated according to the expectations of WG3, and thus of ICAO NTWG. The new draft will be presented no later than at the next WG8 meeting.

56.12 Patents

According to the ISO/IEC rules, all participants of this meeting have been asked, whether they can declare any known patents, unless already done so earlier, which are related to any existing and to be developed standard or draft standard. No declaration has been raised at this meeting.

56.13 Thanking the TF Conveners and Project Editors

WG8 thanks the TF2 Convener Mr. Pascal Roux having achieved in his group further improvements and progresses in course of the maintenance of the standards ISO/IEC 14443 and 10373-6. Also WG8 thanks the Project Editors Mr. Kostas Aslanidis, Mr. Stéphane Jobard, Mr. Daniel Orsatti, Mr. Florian Peters and Mr. Erich Reisenhofer for having done an excellent job to guide the WG8 delegates through the various ballot comments and to prepare the documents for the next voting steps. In particular, WG8 thanks again Mr. Reinhard Meindl, who kindly has taken the role of the Acting Convener of TF3 and has led TF3 to a considerable progress of their tasks.
