STATUS: 96% of eligible members have voted on this ballot. There were 4 negative votes and 2 approve with comments. With 19 voting in favour out of 32 votes cast the ballot has met the voting requirements to pass to the next stage.

However SC17 requires by convention that there are no more than two negative votes.

The SC17 Secretariat requires that WG8 holds a resolution of comments meeting and either 2 negative ballots are resolved and/or a second CD ballot is conducted.
